



2022-2023 INTERNATIONAL STUDENT AMMISSION ANNOUNCEMENT

In accordance with the following statement announced by YÖK, final registration procedures will be conducted. “Candidates who have the opportunity to apply for foreign student admission quotas in accordance with the Principles Regarding the Acceptance of Students from Abroad, and who lost their Turkish citizenship by obtaining a permit to renounce their Turkish citizenship, Candidates who certify that they have a blue card, which is given to those who have lost their citizenship upon their request, and those who have completed their high school education abroad (except for the TRNC) Candidates with dual citizenship, one of which is Turkish, and Turkish nationality can enroll in the programs of Teaching, Law, Medicine, and Dentistry in a way not exceeding 10% of the quota for enrollment.” **Final registration will be made personally by the student and registration by proxy will not be accepted.**

Main Preference Application Dates : 23 - 29 June 2022

Final Registrations of Main Winning Students : 13 July - 12 August 2022 Appointments must be made through the YÖS Online Application Preference System. There will be no registration without an appointment.

Additional Preference Application Dates : 15 - 21 August 2022

Final Registrations of Students Who Won Additional Preferences : 05-23 September 2022. Appointments must be made through the YÖS Online Application Preference System. There will be no registration without an appointment.



DESCRIPTIONS:

1. Applications are accepted with OMÜ-YÖS results in additional quotas, [YÖS results of the universities in the link and the result](#) of the Secondary Education Grade Point Average (ONO).
2. Departments with Special Talent Exams;
 - Yaşar Doğu Faculty of Sport Sciences (Department of Physical Education and Sports Teaching, Coaching Education, Sports Management and Recreation)
 - Faculty of Education (Music Teaching, Art Teaching)
 - Faculty of Fine Arts (Graphic, Painting, Ceramics and Glass)
 - State Conservatory (Traditional Turkish Music, Musicology)
3. Special talent exams will be held at the location of the relevant faculties on the day and time specified in the academic calendar and the final registration of the students who are successful in the exam will be made. For final registration to be made, after the relevant faculties send the exam result letter to the Registrar's Office via the EBYS system, registration procedures can be done. These processes should be followed by the candidates.
4. Candidate students are placed in only one program/department, taking into account their order of preference.
5. Ondokuz Mayıs University is free to fill the quotas or not.
6. Candidates who do not have a Turkish language proficiency certificate or whose Turkish level is less than C1 are considered to be leave of absence for one year to improve their Turkish level. Students who receive a C1 certificate from OMÜ-TÜRKÇE at the end of or within this period, or **those who receive and submit a Turkish language proficiency certificate whose equivalence is accepted, start their education in the following semester.** Those who cannot bring documents are given an additional time of 1 year. Students who do not bring their Turkish language proficiency certificate approved by OMU Turkish at the end of 2 (two) years after final registration will be deregistered from our university. Students who do not have a C1 Certificate are considered to be studying Aktive OMÜ Tömer if they bring a document showing that they are registered at Turkish Language Course Centers approved by the Ministry of National Education or Turkish Learning Centers of the Universities. Students who are deemed to be on leave cannot obtain a student certificate and cannot be enrolled in classes.
7. Applications that are not made within the announced period or those that are made with missing/wrong/fake documents will be deemed invalid. If it is detected after final registration, s/he will be dismissed from the University.
8. Students who register with a Temporary Graduation Certificate are required to submit their graduation certificates until one month before the start of the spring semester of the



academic year specified in the academic calendar. At the end of this period, the student who does not submit his/her graduation certificate will be deregistered from our university. In order to register with a temporary graduation certificate, the student's application year must be the same as the temporary graduation year. Enrollment will not be made with temporary graduation certificates obtained in previous years.

9. Candidates who will register with the “Can Graduate Certificate” must submit their documents until the date specified by the Council of Higher Education. The students who do not submit their documents within the specified time will be deregistered from our university.
10. Students with dual nationality are required to obtain a Certificate of Identity Register Copy from the Registration Offices or via the e-devlet system. It is obligatory to state the first nationality in the **EXPLANATION** section of this document. Documents without a statement will not be accepted.
11. If the placed candidates document that they know the Turkish language until the course registration date after final registration, they must make their course registration by creating a password. Students who do not register for a course cannot start their education. [\(You can reach explanations on creating a Password and Course Registration manuel here.\)](#)
12. Placed candidates are required to pay the required tuition fees for final registration. For residence permit and other procedures, **In case they complete their course registration process, they will be able to get their Student Certificates from the Dean 's Office , the Directorate or the Registrar's Office.**
13. For students who do not have a TR ID number or a Foreigner ID number, an ID number starting with 98 must be generated through the YÖKSİS system. This identification number allows the student to appear as a student in YÖKSİS . The relevant student must apply to the Directorate of Migration Management and obtain a Residence Permit identity card. The student must apply the Residence Permit Identity card to the Registrar's Office by a petition. This is important for integrating it into the YÖKSİS system.
14. Students who are registered at the same program at another university in Turkey through the YÖKSİS system will not be able to register.
15. The student has to meet the conditions in the Quota Guide related to the program in which s/he is placed and bring the required documents.
16. Students under the age of 18 (Eighteen) must submit their parents' (Mother and Father) certificate of Consent (Permission) and the original document with Turkish translation approved by a notary or Turkish Foreign Representatives.
17. The original documents required for final registration will not be returned and will be kept in the Archive of the international student affairs office during the student's education



period. In case of discharge or graduation, the original documents will be given back. **For this reason, students who come for registration have to keep copies of the documents they have to submit by using Scanner , photocopy or taking picture.**

18. It is obligatory to submit the equivalency certificate of the high school diploma from the date of registration until one month before the beginning of the spring semester of the academic year specified in the academic calendar. Students who do not submit documents within this period will be deregistered from our university. Students who do not have an equivalency certificate will be considered to be on leave, they will not be registered for classes and will not be able to obtain a student certificate. 19. Candidates who are accepted to the departments of Yaşar Doğu Faculty of Sports Sciences (Department of Physical Education and Sports Teaching, Coaching Education, Sports Management and Recreation) must submit the Medical Board Report with the indication "It is okay for this student to study at the Faculty of Sport Sciences." within 15 days from the date of Final Registration. Students who do not deliver until the deadline will not be able to register for the course and will not be able to get a Student Certificate.
20. The tuition fees paid by the students admitted to the university for registration are never refunded. Failure to obtain a visa or residence in any way, enrollment in another university, change of program and department, renunciation of the student's right to admission, registration of students to Turkish language courses, Turkish learning centers or Turkish Learning Center of our university do not require a refund of the fee.
21. International students enrolled in the university can benefit from general health insurance by paying a general health insurance bonus, if they make a request to the Social Security Institution (SGK) within three months from the first registration date.
22. Final registration will be made personally by the student and registration by proxy will not be accepted. Photographs of students will be taken for the use of face recognition system during registration.

NOTE: The final registration of the candidates who do not meet the application conditions announced by YÖK ([You can find it](#)) will be canceled even if the final registration process has been completed. Applications of Turkish nationals who have completed their entire secondary education (high school) in Turkey or the TRNC, and in this case, dual nationals whose first nationality is Turkish, are not accepted. Applications of those who have been dismissed from a higher education institution in Turkey are not accepted either. If the students with blue cards who have completed their secondary education (high school) in Turkey or the TRNC do not have a Blue Card on the day



they enter YÖS yet, their exam results will be invalid, and even if they win with this score, their registration will not be made.

SCORES

Mathematics, basic learning skills, and equally weighted score types on OMÜ-YÖS are taken as a basis for placement in preferred programs. The score types of the departments are specified in the quota list.

PLACEMENT:

OMÜ-YÖS exam results for the main placements (1st placement), the results of other national and international exams, with the priority being OMÜ-YÖS exam for additional placements (2nd placement), and the Secondary Education Grade Point Average (GPA) for the vacant quotas after this placement process, if approved by the Ondokuz Mayıs University Senate will be carried out. A separate academic calendar will not be made for this registration.

DOCUMENTS TO BE REQUESTED FROM WINNING STUDENTS DURING FINAL REGISTRATION:

Final registration will be made in person (by the student), and registration will not be made by proxy.

1. Pre-registration Form ([Click to download](#)).
2. Original high school diploma, Original Turkish Translation of High School Diploma, (approved by the Turkish Republic Notary Public or Turkish Foreign Representatives). Diplomas issued by the Ministry of Turkish National Education do not require translation.
3. Original transcript (Transcript) and its Original Turkish translation (approved by T.R Notary or Turkish Foreign Representatives) Transcripts issued by the Ministry of Turkish National Education do not require translation.
4. Original Turkish Translation of the Passport (Approved by TR Notary or Turkish Foreign Representatives)
5. Photocopy of Residence Identity Card obtained from the Turkish Directorates of Migration Management (Students with a Residence ID Card starting with the number 99... must submit it.)
6. Certificate of identity register copy for candidates who are citizens of the Republic of Turkey, dual nationality and have blue card.
7. Students who are citizens of the Republic of Turkey and have completed their entire high school education abroad (except TRNC) are required to obtain a *Certificate of Entry and*



Exit to the Homeland from the General Directorate of Security page via the e-devlet system. This document must be obtained in a way that it covers the High School Start and End dates.

8. Health Board Report is required for the candidates accepted to Yaşar Doğu Faculty of Sports Sciences (Departments of Physical Education and Sports Teaching, Coaching Education, Sports Management and Recreation) ([Click to see the report sample](#))
9. Turkish language proficiency certificate (C1 level) Certificate, (Candidates who have a C1 level certificate obtained outside of our university must obtain equivalence approval in Turkish Application and Research Center, Ondokuz Mayıs University. ([Click for Turkish language proficiency certificate information](#)))
10. "Equivalency Certificate" (High School Equivalency) from the Provincial Directorates of the Ministry of National Education of the Republic of Turkey or the Turkish Foreign Representatives, stating that they are at the level of those who have completed their High Schools in Turkey. This document must include QR code, electronic signature, Verification code or wet sign and sealed. ([Click for Equivalency Certificate information](#))
11. Those who are TRNC nationals and reside in the TRNC and have completed their secondary education in the TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results by registering and studying at colleges and high schools in other countries between 2005-2010, must bring a GCE AL result document and a copy of its certified Turkish translation by Turkish notary or foreign representatives of the Republic of Turkey.
12. The original of the exam result document (National and international exams except for OMÜ-YÖS, such as SAT, ABİTUR, BAKALORYA, YÖS EXAMS of OTHER UNIVERSITIES, etc.).
